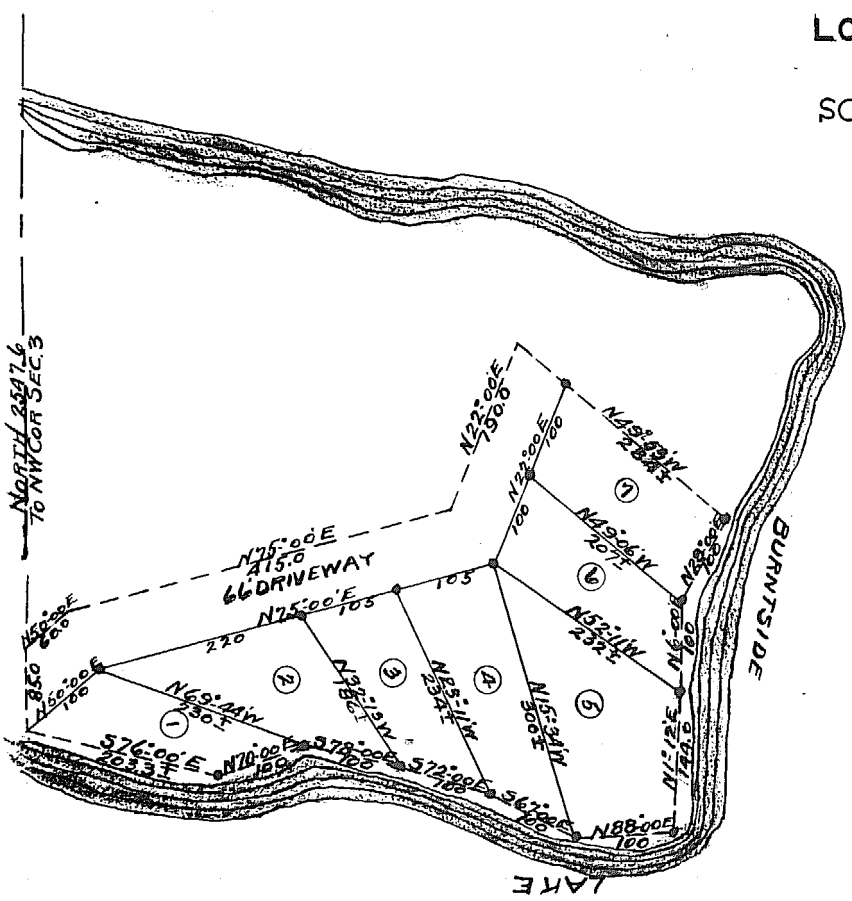


LINDSKOG RESORT

PLAT DEDICATION

KNOW ALL MEN BY THESE PRESENTS:- That Mrs. Erick Lindskog, a widow, being the owner of the following described property, lying and being in the County of St. Louis and State of Minnesota to wit: Lot 2; Section 3, Township 63 North, Range 13 West of the 4th Principal Meridian, according to the United States Government survey thereof, and being desirous of platting the parcel described thusly:- Traversing Starting at the Northwest (NW) corner, Section Three (Sec. 3), Township Sixty-three North (63N), Range Thirteen West (13W), thence South along the Westerly line of Sec. 3 for a distance of 2547.6 feet, to the point of beginning thence North along said section line for a distance of 85.0 feet; thence North 50 degrees 00 minutes East for a distance of 60.0 feet; thence North 75 degrees 00 minutes East for a distance of 415.0 feet; thence North 22 degrees 00 minutes East for a distance of 190.0 feet; thence South 49 degrees 53 minutes East for a distance of 284 feet more or less; thence Southerly and Westerly around the lake shore 845 feet more or less to a point 203.3 feet and south 76 degrees 00 minutes East from the point of beginning thence North 78 degrees 00 minutes West for a distance of 203.3 feet to the point of beginning; said tract containing 4.87 acres more or less, into lots, have caused the same to be surveyed and the annexed plat thereof to be made in accordance with the statutes in such cases made and provided. Now therefore do we hereby ratify and confirm in all respects said survey and the plat thereof as "Lindskog Resort" and sign, seal, and execute said plat and hereby dedicate to the public the use of the street herein delineated.
